In continuance of our earlier Circular No. No.BGTA/AGM-51/2014-2015/141 dated 9<sup>th</sup> September 2015 **we would like to inform you that following few changes have been made in the guideline and norms for the conduct and smooth election for the year 2014-2015.**

1 Proxy will be allow as per the Norms for Voting for Election mentioned in the Annual Report of BGTA (Page No.65) and duly certified by the Directors/Partners/Proprietor and authorize representative of the transport companies.

Proxy Form is the public documents and if any member of BGTA want the copy of the proxy nomination the same will be provided by sending written request as well as the payment of Xerox and administration charges. Any member who submit the false declaration they are solely liable for any criminal act or civil act the election staff and Staff of BGTA will not responsible for the same

The verification of proxy will be done as per the special majority decision taken by the members during the meeting on 15<sup>th</sup> September 2015 for verification will be done in good faith and only members signature will be verified form the record and if any discrepancy in the signature, then members/director/proprietor or person who issue the proxy form will be called by the election staff on his/her mobile

**IMPORTANT NOTE :** Any members who give false declaration/submit, that false declaration regarding proxy person is employee of the particular members and their after it will found to fake/forged/or any fraud other members who had obtain the photo copy has legal right to prosecute the person who issue the false/forged/fabricate proxy the election staff or BGTA staff will not be involve any manner they can issue valid receipts for the proxy form xerox copy collected from the BGTA office
