WITHDRAWN THE CALL FOR NATIONWIDE CHAKKAJAM FROM MIDNIGHT OF APRIL 8, 2017.

This has reference to the Nationwide Chakkajam call midnight of April 8, 2017. There were protracted negotiations and discussions with Ministry of Road Transport & Highways and Ministry of Finance by one team of our apex body All India Motor Transport Congress at New Delhi comprising Shri S. K. Mittal - President, Shri Kultaran Singh Atwal, Honorary Chairman, Shri Harish Sabharwal, VP (NZ), Shri Gunjeet Singh Sangha, MC Member

Another team comprising Shri Bal Malkit Singh, Chairman - Core Committee & Former President, Shri Mukesh Dave, VP (WZ), Shri Amritlal Madan, Chairman - Coordination, Shri G R Shanmugappa, Former President, Sh Gopal Naidu, MC Member and Shri Mukesh M Shah engaged IRDA at Hyderabad.

With kind intervention of Shri Pon Radhakrishnan, Hon'ble Minister of State, Ministry of Road Transport & Highways, Shri Mansukh L. Mandviya, Hon'ble Minister of State, Ministry of Road Transport & Highways, Shri Santosh Gangwar, Hon'ble Minister of State, Ministry of Finance, Shri Sanjay Mitra, IAS, Secretary to Government of India, Ministry of Road Transport & Highways, Shri Abhay Damle, IRS, Joint Secretary to Government of India, Ministry of Road Transport & Highways and Shri N. Balasubramanyam, I.P.S., Transport Commissioner, Govt of Andhra Pradesh the issues were sorted out.

1.0) The major demand of transport fraternity for reduction of arbitrary steep proposed hike of 50% in Third Party Premium by IRDA has been acceded to and it has been capped at upper limit of 27%.

2.0) IRDA has agreed to form a consultative committee having representation from Ministry of Road Transport & Highways, Ministry of Finance and five members of AIMTC to discuss issues of transport sector viz., TPP hike, Claims matter etc.

3.0) To address all other operational issues of the trade the Ministry of Road Transport & Highways has instituted a Standing committee under the chairmanship of Joint Secretary (RT), MoRTH so that these are addressed in an expedite manner alongwith monthly review of the progress made in that regard.

In consideration of the hectic negotiations and developments in the past two days the core committee has unanimously decided to withdraw the call for nationwide chakkajam from midnight of April 8, 2017.
